● **Genworth**, our new favorite whipping boy, is in the process of expanding its Care Scout network to all 50 states – a move projected to be completed by the end of this year. Then, the Care Scout subsidiary will get into the business of offering long term care insurance coverage, with policyholders entitled, in some manner yet to be described, to a benefit of discounted prices for care services, as negotiated by Care Scout. The services will be provided by those companies willing to accept Care Scout's pricing structure. John Hancock used to do this too, but it was only a list of participating providers, many of whom did not operate in all 50 states.

If you're interested in history, my first LTCI affiliation, the old Finger Lakes Long Term Care now MedAmerica (Excellus), started out in the business behaving like Blue Cross & Blue Shield. No surprise, it was all they knew! The first policies FLLTCI issued paid for care in participating nursing facilities, all the best in Monroe County, at a reimbursement rate of 80% of the monthly cost of care. If **Genworth** is able to negotiate, and include in policy language, reimbursements based on care provided by Care Scout companies where there's little or no co-pay, that would be a definite bonus. However, it assumes market forces (not to mention brains and common sense) not in evidence today. We will update as details emerge.
